**During its third season , American Public Square presented five "Dinner at the Square" programs in partnership with the local Kansas City Public Television station, KCPT; five "Conversation at the Square" programs, four of which were done in partnership with the local Kansas City Public Radio station, KCUR 89.3; and 11 additional events. The organization hosted its events in six different venues around the Kansas City metropolitan area. Total attendance for the season increased by approximately 60% to 3,202.**
