FACT SHEET COMPILED BY CHRIS LEBEAU, UMKC RESEARCH LIBRARIAN (RET.) When it comes to the legislative processes, who is really in control – local, state, or federal lawmakers? "Preemption" occurs when a higher level of government removes regulatory power from a lower level of government.

By way of example, we know that Kansas City has a problem with gun violence, and while our new Mayor is working to address it with innovative policies, the balance of power between federal, state and local government is complicated in America.

How does a city or county effectively navigate these dynamics to create safe, healthy, and equitable communities, especially when there isn't always agreement among lawmakers at each level? Can local governments in the metro area truly move the needle on topics like gun violence, affordable housing, and mental health care when they run the risk of having local efforts pre-empted at the state and federal level?

WHAT IS PREEMPTION?

Preemption occurs when a higher level of government supersedes the authority of lower levels.

The Supremacy Clause of the US Constitution gives the federal government the privilege of preempting state law. In the same manner, state government has authority, through the constitutions and statutes, to create laws for the state, cities, counties and other jurisdictions. States can both grant and limit the power of cities.

As with federal law, states may create a minimum standard law which local government may modify to meet local needs. This **"floor preemption"** is the more traditional form of preemption. For example, in many states, cities enact ordinances the supplement state law for childcare licensing.

A state can also exercise **"ceiling preemption,"** barring local government from "requiring anything more than or different from" the higher level law.⁽¹⁾ For instance, the Missouri state statutes ban "the entire field of legislation touching in any way firearms, components, ammunition and supplies to the complete exclusion of any order, ordinance or regulation by any political subdivision of this state."⁽²⁾

"Blanket preemption" occurs when a state has no law addressing a particular issue but still forbids lower levels of government from enacting regulations on its own. For example, lowa state law has no regulation requiring employers to provide paid sick leave and prohibits local government from establishing any such regulations.⁽³⁾

Preemption can serve a positive purpose. The federal Civil Rights Act (1964) and the Voting Rights Act (1965) preempted states and cities from enacting discriminatory laws. On the other hand, preemption can block a city's ability to take corrective action on issues or to experiment with innovative local regulations which may benefit the state later. Local referendums can be overturned, denying voters a voice.⁽⁴⁾ During the period 2015-2017 both St. Louis and Kansas City residents voted for a higher minimum wage than the minimum wage set by state of Missouri. The state legislature passed a minimum wage preemption law several days after the Kansas City vote causing the vote to be struck down in the courts.

Researchers find that over the past 20 years the nature of state preemption has changed.


Lawmakers are quicker to preempt local government action "when it does not suit their political, social, or economic beliefs or agendas." Industry-backed "special interests have significantly increased their lobbying efforts at the state level" and across multiple states.⁽⁵⁾ The NRA and the Plastics Industry are two such examples. Forty-five states⁽⁶⁾ have enacted preemptive firearms laws to prohibit local government from implementing tougher gun regulations.

State and city tensions appear to reflect Democratic-Republican splits. Democrats cluster in urban areas where problems beg for solutions not required elsewhere while Republicans tend to occupy suburban and rural areas.⁽⁷⁾ "National-level polarization...is pushing conflict down to states and localities." When decision-making is divorced from the core wants and needs of community members, it creates a perilous environment.⁽⁸⁾

MO Rev Stat Article X, sections 16-24 ⁽⁹⁾	Law ties city and county budget increases to inflation, capping the amount of property tax revenue officials can raise without seeking a vote of citizens. How Policy Decisions Impact Poverty

Housing Preemption Laws:


- Inspection Restrictions: Prohibition of Local Ordinances Requiring Inspections of Private Residences (KSA 12-16,138 (2016))
- Mixed-Income Housing: Prohibiting Rent Control or Control of Real Estate Purchase Price by Political Subdivisions (KSA §12-16,120 (2016))

Employment Preemption Laws:

- Paid Leave: Prohibiting cities and counties from requiring employers to provide employees paid sick days or paid family leave. (KSA §12-16,130 (2013))
- Minimum Wage: Prohibiting cities and counties from raising their local minimum wages above Kansas' state minimum wage. (KSA §12-16,130 (2013))
- Fair Schedules: Prohibiting cities and counties from establishing any laws governing work schedules such as laws requiring employers to give advance notice of work schedules or pay a premium for requiring workers to be "on call" for shifts. These laws are often referred to as "fair work scheduling" laws. (Law: KSA §12-16,130 (2016))


States with Enacted Bag Legislation
