	2020, APS produced over 30 programs that reached over 50,000 people on topics ranging from mental health to racism, climate
	change and the looming election. Our general events are always free and open to the public which is important because we
	believe that access to these events is critical to ensuring that the citizens of our community are engaged in the rights and
	resources that enable them to actively participate in civil society.
